NOW, THEREFORE, BE IT RESOLVED that the Board of Directors of the East Creek Metropolitan District No. 2 shall and hereby does amend the Budget for the fiscal year 2023 and adopts a supplemental budget and appropriation for the General and Debt Service Funds for the fiscal year 2023, as follows:

General Fund	\$ 12,000
Debt Service Fund	\$ 49,000

BE IT FURTHER RESOLVED, that such sums are hereby appropriated from the revenues of the District to the proper funds for the purposes stated.
